Sl. No.	The school is directed to ensure that:
1	The total number of sections of Bal Vatika shall be restricted to 03 (one sections each in Bal Vatika I, II & III respectively). The total number of sections of the school from class I to XII shall be restricted to 20 of which not more than 1/3rd sections may be used for senior secondary classes. The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension.
2	The school has a basement, which is not suitable for conducting academic activities. Thus, the school is directed not to use the basement for academic activities and submit an undertaking in this regard within 03 months in the compliance.
3	The Composite science lab is set-up on the make-shift tables. It does not have permanent fixtures, washbasin (with water tap) as well as gas connection in the workstation and safety features such as fire extinguisher and exhaust fan. Thus, the school is required to set-up as per Board's SoP within 03 months and submit the compliance.
4	The biology lab does not have permanent fixtures / workstation with attached washbasin. Thus, the school is required to upgrade the same in light of Board's SoP within 03 months and submit the compliance.
5	The school shall conduct training of its teachers with CoE Prayagraj within 03 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.
